**NOTICE OF RACE**

**1. RULES**

- 1.1 The series will be governed by the rules as defined in The Racing Rules of Sailing.
- 1.2 Rule 40 is deleted and replaced by "Competitors are required to wear a PFD while on the water except during brief periods when changing clothing". Code Flag "Y" will not be displayed.
- 1.3 J/105 Fleet #1 Rules will apply.
- 1.4 This is a Fleet #1 Level B event. There is no crew weight limit.
- 1.5 RRS Appendix V1 and V2 will apply.
- 1.6 On the water coaching will be provided. This changes RRS 41 and per RRS 87 J/105 Class rule 7.10 regarding coaching.

**2. ELIGIBILITY AND ENTRY**

- 2.1 The regatta is open to all boats in the J/105 Class.
- 2.2 Late entries will be accepted up to the day of the race.

**3. FEES**

- 3.1 Entry fee is \$250.00 per weekend or \$650 for the entire series of three weekends.

**4. INTENDED SCHEDULE**

- 4.1 Dates of racing are Sat & Sun August 22-23, September 12-13, October 3-4, 2020
- 4.2 Number of races: Practice start followed by 3 races are scheduled each day.
- 4.3 The scheduled time of the warning signal is:  
11:00AM Practice Racing Start 1st Warning each day.  
11:15AM Racing 1st Warning each day.

**5. SAILING INSTRUCTIONS**

- 5.1 The sailing instructions will be available before 6PM on Thursday August 20, 2020 on line at: (Don will provide link).

**6. VENUE**

- 6.1. Berkeley Circle.

**7. COURSES**

- 7.1. The courses to be sailed will be detailed in the SIs and will be standard upwind/downwind with a gate above the starting line.

**8. PENALTY SYSTEM**

- 8.1 RRS Appendix V1 & V2 will be used.

**9. SCORING**

- 9.1 No excluded scores. All races will count in scoring the Series.
- 9.2 Two races are required to be completed to constitute this series.

**10. PRIZES**

- 10.1 Prizes will be detailed in the SIs and may be for each weekend and series.

**11. DISCLAIMER OF LIABILITY**

- 11.1 Competitors participate in the regatta entirely at their own risk. See RRS 4, Decision to Race. The organizing authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, during, or after the regatta.

- 12.1 Each participating boat shall be insured with valid third-party liability insurance.
